- c) Complete Section 2 if you have been classified on the 2019/20 FAFSA as a dependent.
- d) Write a 1000-word personal statement that focuses on the following questions:
  - What inspires you to have a career in the music industry?
  - How will your experience at MSU Denver at DIME this upcoming semester benefit your career?
  - What are your personal goals for this semester? Musically and academically?
  - How are you going to improve your studies and career opportunities while on the program?

**PLEASE NOTE:** If you have applied for scholarship funds in the past, you must ensure that your personal statement is original in content.
